# **LICENSE**

If software and/or firmware is accompanied by a separate end user license agreement ("EULA"), then such software and/or firmware shall be governed by such EULA.

### **EVALUATION BOARD STATUS**

The Evaluation Board offers limited features allowing You only to evaluate and test the ST products. The Evaluation Board is not intended for consumer or household use. In case of dispute and in the absence of an amicable settlement, the only competent jurisdiction shall be the Courts of Geneva, Switzerland. #### SEVERABII ITY

Nothing in this Agreement shall create, or be deemed to create, any joint venture, partnership, principal-agent, employer-employee or other relationship between the Parties, except that of independent contractors. ### **SURVIVAL**

### **RECYCLING**
