


Figure 1. X-STM32MP-IOT01A schematic diagram (1 of 6)




Figure 2. X-STM32MP-IOT01A schematic diagram (2 of 6)





Figure 3. X-STM32MP-IOT01A schematic diagram (3 of 6)





Figure 4. X-STM32MP-IOT01A schematic diagram (4 of 6)


Figure 5. X-STM32MP-IOT01A schematic diagram (5 of 6)





Do not use the Evaluation Board until You have read and agreed to this Agreement. Your use of the Evaluation Board constitutes Your acceptance of this Agreement.

LICENSE

STMicroelectronics ("ST") grants You the right to use the enclosed Evaluation Board offering limited features only to evaluate and test ST products solely for Your evaluation and testing purposes in a research and development setting. The Evaluation Board shall not be, in any case, directly or indirectly assembled as a part in any production of Yours as it is solely developed to serve evaluation purposes and has no direct function and is not a finished product. If software and/or firmware is accompanied by a separate end user license agreement ("EULA"), then such software and/or firmware shall be governed by such EULA.

EVALUATION BOARD STATUS

The Evaluation Board offers limited features allowing You only to evaluate and test the ST products. The Evaluation Board is not intended for consumer or household use.
